4. Acceptance of the Non-Profit Conversion

The President explains that the School is a successor to Flagstaff Montessori, LLC, an Arizona limited liability company. Flagstaff Montessori, LLC was a for-profit company that ran the School's four charter campuses based on the Montessori model. In 2021, the former owner of Flagstaff Montessori, LLC, Eric Alexander, determined that the School has a better chance at achieving long-term sustainability as a nonprofit corporation with an invested, independent board of directors who can guide it into the future. On January 9, 2021 the Arizona State Board for Charter Schools approved a charter amendment request approving a change in ownership from Flagstaff Montessori, LLC to Flagstaff Montessori (the independent Arizona nonprofit corporation). On February 18, 2022, the Arizona Corporation Commission approved the conversion of the Flagstaff Montessori, LLC to Flagstaff Montessori, an Arizona nonprofit corporation. A copy of the Statement of Conversion and the Articles of Incorporation are attached.

5. Governance Policy Manuals

The Governance Policy Manual is designed to help the school comply with the law and best practices, and also permit the school to provide positive responses on its form 1023 tax exemption application and its annual Form 990.

The Conflict of Interest Policy is a de facto IRS requirement for all exempt organizations and must be completed by each member of the board on an annual basis. The Whistleblower and Record Retention Policies are intended to help the school comply with Sarbanes Oxley. The Compensation, 990-Review, and Travel and Expense Policies are asked about on Form 990 (the school's annual tax return). Presentation, discussion, and possible action to adopt the Governance Policy Manuals.

6. Depository of Funds

The board will discuss to designate a depository for the funds of the School and to authorize certain officers to deal with the corporate funds.

Further, so long as Eric Alexander has contracted with the School to provide business management services and unless the Board of Directors of the School declares otherwise, Eric Alexander shall be listed as an authorized signatory on the School's bank accounts.

7. Application for Recognition of Tax Exempt Status, 501(c)(3) of the Internal Revenue Code of 1986, As Amended

Flagstaff Montessori is organized and will operate exclusively for charitable and educational purposes.

The School will file an application for recognition of its exempt status on Form 1023 with the Internal Revenue Service. Flagstaff Montessori shall cause its attorneys to forthwith process an application for tax exemption under IRC Section 501(c)(3) and in connection therewith the appropriate officers of the Flagstaff Montessori are hereby authorized and directed to execute application forms, powers of attorney and any other necessary documents.
